#### **Meeting Summary**

**Business Plan Update** A business plan update on technical assistance and education outreach was provided by Mr. Watermeier. Technical assistance and education outreach was identified as one of the four strategic goals. The goal from the strategic plan stated, “facilitate technical assistance and education outreach opportunities for furthering the adoption of Nebraska Spatial Data Infrastructure (NESDI) data layers and geospatial applications.”

#### **Working Group Updates**

The NebraskaMAP group reported several policy related topics are coming from the various working groups involving the NESDI layers, data sharing, legislative initiatives, and NebraskaMAP. Mr. Watermeier has developed policy related questions that he will send to council members. The Council will need to determine which topics are policy or merely tasks associated to implementation of the plans. The Street Centerline-Address Database group worked with Department of Roads to complete a county pilot project for Jefferson County using PSC street data with the department’s data. Several conflicts of the data were discovered particularly in urban areas. The Department of Roads is working to obtain approval in the overall QA/QC process for the street centerline workflow of this project. The Land Records working group is working with the State Surveyors office and discussing having a presentation on survey and geodetic control issues pertaining to the NESDI layers. It is planned to have an update and presentation at our next meeting on this topic. The USDA-FSA NAIP cache has been completed and is in progress to be uploaded to NebraskaMAP. The NIROC vendor is 55% complete with the flight acquisition project with Pictometry. The estimated delivery of data is early June and will most definitely be available to partners by end of July. The elevation working group is working with State Purchasing to get the RFI out in the coming week.

**Updates from Member Agencies** Various updates were provided by agencies and are included in these minutes.

**Other Business Items** The OCIO office reported that the Esri Master Purchase Agreement is at Purchasing for review and information will be sent out when the agreement is finalized. Meanwhile, continue to use the existing purchase agreement.

#### V. Working Group Reports and Discussion

<b>DISCUSSION</b>	<p><b>NebraskaMAP - Jeff McReynolds.</b> The technical group did not meet since last council meeting. Several policy related topics are coming from the various working groups involving the NESDI layers, data sharing, legislative initiatives, and NebraskaMAP. Mr. Ohmberger reported that he has been in discussions with Nathan Watermeier, Jayne Scofield and Brenda Decker from the OCIO regarding policy efforts. Mr. Watermeier has developed policy related questions that he will send to council members. The Council will need to determine which topics are policy or merely tasks associated to implementation of the plans.</p> <p><b>Street Centerline-Address Database - Rose Braun.</b> The Department of Roads has completed a county pilot project to compare the Public Service Commission’s data of Jefferson County with our Department’s data. There were 46 conflicts. Most of them were in urban areas. We assume those may have occurred because the Public Service Commission data is several years old and the Department of Roads receives lane mile reports of city updates annually. The next step is to meet with our administration for approval to continue to work on this project. We will then meet with Nathan to follow up with work details. The Street Centerline Work Group’s next meeting is scheduled for April 23.</p> <p><b>Land Records - Eric Herbert.</b> The Land Records group and others are working with the State Surveyors office and discussing having a presentation on survey and geodetic control issues pertaining to the NESDI layers. It is planned to have an update and presentation at our next meeting on this topic.</p> <p><b>Imagery - Mike Schonlau.</b> The USDA-FSA NAIP cache has been given to Mr. Watermeier. Council members will receive a notice when it is fully uploaded and available. Mr. Schonlau suggested posting information on how to access this information on the GIS web site. The NIROC vendor is 55% complete with the flight acquisition. With the cooperation of the weather, it is anticipated the project will remain on track. The estimated delivery of data is early June and will most definitely be available to partners by end of July.</p> <p><b>Elevation - Josh Lear.</b> The RFI is currently being reviewed by State Purchasing and will be sent out in the coming week. After it has been approved, it will go out to prospective LiDAR vendors.</p>

**VI. Updates from Member Agencies****DISCUSSION**

Lincoln/Lancaster County, Jeff McReynolds. The city is continuing with the AVL project. The project will be upgrading to 10.1.

Nebraska Department of Roads Report, Rose Braun: Michael Niedermeyer has been working to migrate the Right of Way project to ArcGIS Server and testing the migration of NECTAR, our internal web portal to ArcGIS Server. The GIS-T Conference will be held May 5 – 8 in Boise, Idaho. Late registration fees go into effect on April 12. For program details, go to [www.gis-t.org](http://www.gis-t.org).

Office of the CIO, Jim Ohmberger. The OCIO has been working on master licensing agreement for address points data base software but is having difficulty recruiting financial partnerships. Mr. Watermeier has sent information to key stakeholder agencies but has received no feedback. The council discussed benefits of the purchase as well as the implementation plan for the software and who will be responsible for the plan. Mr. Schonlau indicated that when MAPA purchased software from the same vendor, they solicited financial partners after the purchase. Data sets were useful but difficult to find someone to leverage the use of the data. It was agreed to develop a statement of endorsement and resolution to be voted on at the next meeting.

Conservation and Survey Division, Les Howard. The 2012 ground level water data is now available on their website.

Sarpy County GIS, Eric Herbert. Sarpy County is in the design mode for the CAMA project application for planning and zoning. The design phase has gone well. The project is approximately 6 weeks from the go-live date.

Department of Natural Resources, Steve Rathje. The agency field offices have been testing GIS on mobile devices for field offices GIS. The agency has decided to go with laptops due to the visibility of the screen.

GIS/LIS, Mike Preston. The GIS Symposium will be held April 16th-18th. Mike Turner, from AppGeo, is the keynote speaker. Presenters for workshops are still needed if you are interested visit the web site or contact any of the Symposium planning members.

Game and Parks Commission, Sudhir Ponnapan. There poster has been updated and is on the website.

Douglas County/Omaha Metro, Mike Schonlau. Douglas County data has been submitted to ESRI. City and county entered into CityWorks agreement and are implementing a mobile version for IOS devices. Omaha Metro just completed an Impervious Surface Mapping project with Merrick out of Colorado. If anyone is interested in the data and how it looks, they were asked to contact Mr. Schonlau.

Nebraska State Patrol, Kyle Otte. The AVL software has been deployed and it is proving to be a great benefit to dispatchers and troopers.
